

MANDATE / ENTREPRENEUR

1. I, the undersigned, _____, hereby give mandate to "Bohbot & Associates" to represent me regarding all matters in relation with my immigration to Canada in the category of the "Entrepreneur" program.

2. It is agreed that the present mandate will be the following:

- a) Preparation of all documents relevant to my application as immigrant to Canada,
- b) Presentation of the file to the Quebec or Canadian Immigration Department,
- c) Once the business proposal is accepted by the Immigration Department, preparation of the Application for Permanent Residence.

3. I agree to pay the sum of _____ American Dollars (U.S. \$ _____) in the following manner:

- a) Fifty percent (50%) at the opening of the file,
- b) Fifty percent (50%) upon acceptance of my business proposal by the Quebec Immigration Department.

3.1 The fees hereinabove described do not include any and all disbursements to be paid to the Quebec or Canada Government for all my family.

Those fees do not include the prospecting trip or the feasibility study.

3.2 In case of default of payment of any amount due to "Bohbot & Associates", I hereby authorize and mandate irrevocably "Bohbot & Associates" to advise the Immigration Authorities to close and cancel my immigration file.

4. I acknowledge the fact that "Bohbot & Associates" did not make any promises or guarantee any delay in obtaining of the visa, and that their services consist only in so far as obtaining an immigrant visa for myself, my spouse and my unmarried children under 19 years of age or over if they are full time students.

5. I declare that I was informed by "Bohbot & Associates" that I will receive a conditional visa that will oblige me to open a business within Two (2) years of my landing.

I engage myself to send all pertinent documentation and fees required by the Canadian Embassy and or Quebec Delegation within fifteen (15) days maximum from the reception of the file from "Bohbot & Associates".

6. I declare that all information mentioned in my application are true and that I have the experience and the necessary funds to qualify as an entrepreneur presently and until my interview date.

I will not postpone my interview with the Immigration Authorities unless agreed with "Bohbot & Associates".

I shall also inform immediately "Bohbot & Associates" of all communication and correspondence received from the Quebec Delegation or the Canadian Embassy, and I will follow the instructions of "Bohbot & Associates" before replying to them.

I will give to "Bohbot & Associates", within forty-five (45) days of the present, all the documents needed. I will also give immediately all documents needed by "Bohbot & Associates" for the success of my Application.

7. Subject to what is contained in paragraph 6 hereinabove, if I am invited to attend to an interview but I am not accepted after such interview, "Bohbot & Associates" shall immediately refund to me all fees paid directly to them as mentioned in clause 3, less One Thousand American Dollars (US\$1,000.00).

If I change my mind regarding my Application for any reason whatsoever, or if my Application is refused because I did not respect the present mandate or because of criminal or medical reason for myself or any member of my family, no amount whatsoever shall be refunded.
